## FUTURES OF SCHELLING CONFERENCE

German philosopher Friedrich Wilhelm Joseph Schelling (1775-1854) was once considered a minor figure or, as Slavoj Žižek put it, a "vanishing mediator", between Hegel and Heidegger. Today he is regarded as a seminal thinker in 19th century German philosophy. *Futures of Schelling*, the North American Schelling Society's second annual conference, will address his pivotal role in reconceptualising the work of his contemporaries and predecessors and the way in which he informs current philosophical, theoretical and interdisciplinary thinking.

*Futures of Schelling* has been organized by The Centre for Theory and Criticism and McIntosh Gallery at Western University, in collaboration with the North American Schelling Society, with funding from the Rotman Institute of Philosophy, Romanticism at Western, Faculty of Arts and Humanities, Faculty of Social Science, Department of English, Department of Philosophy and Religious Studies (Kings College University), Department of Philosophy, Centre for Advanced Research in European Philosophy (Kings College University), Faculty of Information and Media Studies and the Department of Modern Languages and Literatures.


